

New Student Application fee: A **non-refundable** \$50 processing fee is due at the time of application.

Registration: (K-8) A **non-refundable** registration fee of \$300.00 first child \$275.00 for each additional child for new and returning students must be paid in full before registration is complete. The Registration Fee is required when the Application is submitted. It is a **non-refundable** unless FMCS does not admit the student. The fee covers student insurance, accreditation costs, one yearbook per family, book fees, student ID cards and school-wide standardized tests costs. (Additional yearbooks can be purchased for \$40.00 each)

Pre-K 3-4 Registration: A **non-refundable** registration fee of \$150.00 for each child (no discounts given) to be paid when registering.

Volunteer hours: Parents are required to volunteer 10 hours per student. If this is not completed by March 29, 2013 your account will be billed \$200.00 per student.

Financial Assistance:

FMCS accepts the Florida Step Up For Students Scholarships! You can log on to www.stepupforstudents.org and find out more information. A limited amount of Financial Aid is available based on need and the recommendation from the Financial Aid for School Tuition Company. Please note timing is very important refer to Financial Aid packets for information. Financial Aid is available to students in grades K through 8th and cannot be used in conjunction with any other discounts or with the Step Up For Students Scholarship or McKay Scholarship. The Financial agreement will be signed when the award is accepted.

K - 8th Discounts: You may apply for **only 1 discount, whichever is the greatest:**

- A sibling discount on base tuition is applied to each successive sibling enrolled at FMCS. (see chart below)
- Discount given on base tuition to children of any full-time pastor. (Contact Mrs. O'Brien)
- A \$300 discount to First Assembly of God tithe paying members
- A 10% discount given to children of FMCS alumni.

Learning Disabilities Program, K-8 th grades
A program to assist students with mild disabilities who struggle academically <u>within the regular classroom</u> . There are 5 levels of service which range in cost starting at \$500. See brochure for additional information.

Payment Terms: The F.A.C.T.S. tuition management program is set up on **ALL** monthly accounts. Payments are due on the 5th or 20th of each month. **The annual fee, determined by F.A.C.T.S., is deducted when F.A.C.T.S. receives the agreement.** F.A.C.T.S. accepts withdrawals from: Credit Cards (Discover, MasterCard or American Express), Debit Cards, Checking Accounts and Savings Accounts. FMCS also accepts Visa, MasterCard and American Express as forms of payment.

Note: When insufficient funds occur a \$50 charge is added each month until the account is in good standing. Payments begin in either June or July depending on your payment plan. All payment plans end in May. Your student(s) will not be allowed to re-register for the next school year unless your school balance is zero. This includes after care, morning care, lunch, all fees, tuition and any other applicable outstanding balances.

Tuition payments for students entering FMCS after the school year has begun will be prorated based upon the multiple payment rate unless paid in full at time of entry. Students withdrawn or dismissed from FMCS during a given month will be charged for the full month's tuition. Each account must be kept at a monthly zero balance for a student to attend classes, take exams, and receive his /her quarterly report card or have student records released and transcripts mailed. Upon withdrawal or dismissal all records will be held until the account is paid in full. Lost or damaged book charges will be added to the account.

Other Fees:

Late Payment Fee: A \$25.00 late charge will be added on any account that is more than 15 days in arrears.

Financial Change Fee: A \$100 fee will be charged to change a signed Financial Agreement.

Return Check Fee: A \$25.00 charge will be assessed for each returned check.

Withdrawal Fee: A \$500.00 fee will be charged per student being withdrawn or dismissed before July 1, 2012 and \$750 if you withdraw after July 1, 2012. In addition to the withdrawal fee any balance remaining on additional fees (library and lunch charges) will need to be paid at that time.

Sports Fee: A fee of \$50 per sport, per student will be charged for all athletic team sports at FMCS. The sports fee must be paid prior to a student participating in the first practice of that sport. This fee is set up to cover insurance and misc. expenses as a result of that sport.
